AN ORDINANCE OF THE COUNCIL OF THE CITY OF SHARON, COUNTY OF MERCER, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE CITY OF SHARON TO ENTER INTO COOPERATIVE INTERGOVERNMENTAL AGREEMENTS BETWEEN IT AND THE CITY OF HERMITAGE AND IT AND THE BOROUGH OF SHARPSVILLE, THE TOWNSHIP OF SOUTH PYMATUNING, THE UPPER SHENANGO VALLEY WATER POLLUTION CONTROL AUTHORITY AND THE COUNTY OF TRUMBULL RELATIVE TO PROVIDING ADMINISTRATION OF THE CITY'S INDUSTRIAL PRETREATMENT PROGRAM.

BE IT ORDAINED AND ENACTED by the Council of the City of Sharon, and it is hereby ordained and enacted by the authority of the same as follows:

SECTION 1. AUTHORITY, TERMS AND CONDITIONS: The City of Sharon is hereby authorized and empowered to enter into Intergovernmental Agreements (copies attached) between it and the City of Hermitage and it and the Borough of Sharpsville, the Township of South Pymatuning, the Upper Shenango Valley Water Pollution Control Authority and the County of Trumbull for the purpose of providing for the administration of the City's industrial pretreatment program

SECTION 2. DURATION OF THE TERM OF THE AGREEMENT: The term of the Agreement shall be indefinite.

SECTION 3. PURPOSES AND OBJECTIVES: The purpose of the Agreement is to provide for the enforcement of the City's industrial pretreatment program.

SECTION 4. MANNER AND EXTENT OF COOPERATION AND OF FINANCING THE AGREEMENT: The Agreement will be completely financed with user charges and license fees.

SECTION 5. DISPOSITION OF PROPERTY UPON TERMINATION OF THE AGREEMENT:
The participating municipalities will not acquire any joint property under the Agreement.

SECTION 6. SEVERABILITY: The provisions of this Ordinance shall be severable and, if any of the provisions hereof shall be held unconstitutional, void or otherwise unenforceable, such shall not affect the validity of any of the remaining provisions of said Ordinance.

SECTION 7. REPEALER: All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance are hereby repealed insofar as the same affect this Ordinance.

SECTION 8. EFFECTIVE DATE: This Ordinance shall become effective immediately.
