AN ORDINANCE OF THE COUNCIL OF THE CITY OF SHARON, COUNTY OF MERCER, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE CODIFIED ORDINANCES OF THE CITY OF SHARON, PART TWO, "ADMINISTRATION CODE," TITLE TWO, "GENERAL PROVISIONS," CHAPTER 209, "GENERAL FEE SCHEDULE," SECTION .04, "SCHEDULE," TO CHANGE THE FEE FOR CERTAIN ENUMERATED SERVICES OR MATERIALS SUPPLIED.

BE IT ORDAINED AND ENACTED by the Council of the City of Sharon and it is hereby ordained and enacted by the authority of the same as follows:

SECTION 1. AMENDMENT: The Codified Ordinances of the City of Sharon, Part Two, "Administration Code," Title Two, "General Provisions," Chapter 209, "General Fee Schedule," Section .04, "Schedule," is amended with respect to the following items:

SECTION 2. AMENDMENT: The Codified Ordinances of the City of Sharon, Part Two, "Administration Code," Title Two, "General Provisions," Chapter 209, "General Fee Schedule," Section 04 is amended to Delete, in their entirety, the following items: 8, 9, 10, 13, 14, 15, 16, 17, 18, 21, 22, and 46

SECTION 3. SEVERABILITY. The provisions of this Ordinance shall be severable and, if any of the provisions hereof shall be held unconstitutional, void or otherwise unenforceable, such shall not affect the validity of any of the remaining provisions of said Ordinance.

SECTION 4. REPEALER. All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective ten (10) days after final passage and approval by the Mayor where such approval is required.
