Public Hearing for Ordinance #10-08

An ORDINANCE of the Council of the City of Sharon authorizing the incurring of Lease Rental Indebtedness for the benefit of the City of Sharon Sanitary Authority in the presently estimated amount of \$3,300,000 and summarized as follows:

Article 1 defines certain terms, including the Guaranty Agreement and the Project. The Project consists generally of the design and construction of a new wastewater treatment plant.

Article 2 authorizes the incurrence of lease rental indebtedness by the execution of a Guaranty with the Authority.

Article 3 provides for the private sale by negotiation of Bonds of the Authority and sets forth certain directions for settlement.

NEWS MEDIA:

The Herald – Inquired about clarification for police cruiser lease amount and annual payment. Clarified amount for street sweeper.

CITIZENS:

Rol Curry – Inquired about the police cruiser lease payment and if the payment amount is negotiable. Lt. Smith explained the financing.

Carol Swartz – Asked if City Council would consider going back to the original format for their meetings (combined workshops/meetings). Mr. Heutsche advised that Council would discuss it.

Tom Ristvey – Asked if Council was going to discuss rental service fees for licensing rental properties. Mayor Lucas advised that Council will review his proposed fee schedule and will hold discussion at March’s Council Meeting. Mr. Ristvey stated that five years ago Council implemented the licensing fee and said that \$3.00 would cover the paperwork and complained that now they are discussing \$50.00 for the cost or having an independent inspector do the inspection, who in turn will charge the landlords a high fee. Mr. Heutsche stated that he understood his concerns and that they are discussing “self-certification” to alleviate further financial burdens on landlords. He recognized that there are some good landlords, but that there are also some “slum lords.” He stated that Council is trying to find a way to make it fair. He stated that Council will discuss it further at the March workshop.

MAYOR LUCAS:

Requested that Council review his proposed fee schedule for next month’s Council meeting. Announced that there is an opening in the Street Dept. due to a retirement. The City will be using Mercer County Career Link if they need to replace (due to bumping rights in AFSCME union, may not need to replace). He also stated that the position required a CDL.
