PUBLIC COMMENTS - AGENDA ITEMS

Courtney Saylor, 362 Spencer Avenue, asked for an explanation on Ordinance #11-22 on the agenda for a first reading, amending the Sharon Zoning Ordinance relating to Hotels. Mr. Fiscus said this proposed zoning change was discussed in depth at the July Workshop and creates an overlay for all residential neighborhoods to allow a hotel if specific requirements were met, including a 4-Star or 4-Diamond rating, and offering a level of services and amenities. Ms. Saylor asked if the Ordinance would affect the Shenango Inn. Mr. Fiscus said the Ordinance would affect the entire city and allow for possible development of hotels, as long as all assurances and requirements are met. Ms. Saylor said the Zoning Board passed the variance for a potential buyer of the Shenango Inn who subsequently backed out and asked if this variance is still attached to the property or if this Ordinance will supersede it. Mr. Fiscus said that variance approval was appealed by the City; it went to the County Court, was upheld, and came back to City Council. Mr. Fiscus recommended City Council entertain an Ordinance for a zoning change to lead to a better pathway to go before the Zoning Hearing Board. If the first reading of the Ordinance passes, it will then be sent to Mercer County Regional Planning and Sharon Planning Commission for review, and they will make recommendations to City Council. The City's Zoning Ordinance provides for special exemptions or conditions, and this would become one if it is passed by Council. The new owner would need to make an application to the Zoning Hearing Board and a public hearing would be held in that case.

Ms. Saylor asked about Resolution #64-22, the bid for the Library Roof project. The Keystone Grant covered the roof and other items such as LED lights, security cameras and fire alarms. She asked if these items are covered in this bid. Jason Tomko said those will be separate items. When bids were requested, only roof bids were received; the other items will be addressed later.

James Epstein, 1339 Kimberly Road, said he addressed his opinions regarding the Shenango Hotel project at the last meeting. He thanked Council for taking his considerations into account as well as the assurances if a hotel is developed in the R-1 Zoning District. He thanked Mr. Fiscus for his communications on this issue. The assurances in the Ordinance are specific and will hold any hotel developer to a high standard.

David McLaren, 1113 Haig Street, said there are two motions giving the Library \$550,000, and asked if any other communities are putting money into the project. Mr. Fiscus said no, but other communities do participate in annual allocations to the Library. The City of Sharon is the host and applicant for the grant money; a portion of the money will be financed, and the debt service amount falls within the City's budgeted annual allocation amount. Mr. Sizer said Resolution #64-22 is to approve the project bid and Resolution #68-22 is to approve financing.

Mr. McLaren asked about Resolution #61-22, and if the businesses are established in Sharon or new businesses coming in. Mr. Sizer said one grant will assist with a project to develop student housing for Penn State Shenango; one grant is for a restaurant to add a new location in downtown. Mr. Fiscus said one grant will be used by a current business to construct a new building. Mr. Fiscus said there will be a press release and applicants will be formally notified after Council approves the grants.

Mr. McLaren asked for an updated amount of the spending of the \$14 million of ARPA funds. Mr. Fiscus said this information is read at each Workshop.

Troy Clark, CBD Store Manager, asked if there is a way to overturn the Ordinance that prohibits putting signs on telephone poles. Mr. Fiscus suggested Mr. Clark contact David Tomko and if something comes from that meeting, Mr. Tomko will bring it to Council for review.

Courtney Saylor, 362 Spencer Avenue, said she is grateful for the resurfacing of the roads in her neighborhood. She asked the status of the intersection of Spencer Avenue and Connelly Boulevard. Mr. Sizer said this issue has been discussed at the last three meetings and workshops. There has not yet been any official action; this will take time as a lot of parties are involved. Mr. Fiscus said he has an upcoming meeting scheduled with PennDOT.

Reverend Lisa McCoy of Greater New and Living Way Synagogue introduced herself and Associate Pastor Alvin Eric. She is here to learn more about the City and help the community to be better and safer.

Ben Griffin, 528 Dwyer Way, asked if PennDOT has authority if the City closes Spencer or Service at Route 62. Mr. Fiscus said we would need PennDOT's approval because they intersection with PennDOT streets. Mr. Fiscus said PennDOT collaborates with the City and respects the elected officials of the City of Sharon. Mr. Sizer said this will be confirmed at an upcoming meeting with PennDOT and will be reported at a future workshop.

MR. JAMES: Mr. James said noise from cars is getting out of hand again. He asked if the Ordinance can be reviewed and enforced.

MR. SIZER: None.

MR. KOERTH: Mr. Koerth asked if there is a timeline on the closing on the Wengler Avenue Bridge. Mr. Fiscus said the City was notified recently that it is a permanent closure. Mr. James said the City was notified about four years ago the bridge was in bad shape and the state never did any repairs or upgrades.
