## **PUBLIC COMMENTS - AGENDA ITEMS**

Dave McLaren, 1113 Haig Street; asked about proposed Resolution #78-22 – ARPA grant awards and if there is a list of recipients available. Mr. Fiscus said if the resolution is approved tonight, a detailed press release will go out. He read a list of the recipients under proposed Resolution #78-22:

- Quaker Steak & Lube \$207,500 for business expansion
- Julian's Bar and Grill \$100,000 to open a new restaurant in the former Lulu Beans building
- Gilbert's Risk Solutions \$100,000 for façade improvements which will also open up the Riverwalk
- The Winner Inc. \$100,000 for facade improvements
- Thyme in Your Kitchen \$87,500 for façade and HVAC improvements
- Webb Winery- \$70,000 business expansion in the former Billy's Black and Gold building where wine will be produced, and a future testing room added
- Laurel Technical Institute \$45,000 for creating a cooperative kitchen incubator
- Lisac Properties \$24,226 for façade improvements and business expansion
- Wandering Soul Books, Gifts and Furniture \$20,000 for a new gift shop and bookstore
- Stylishly You \$12,500 for a new hair salon
- Evolve Fitness \$9,000 for business expansion.

Mr. McLaren asked about proposed Resolutions #79-22 and #80-22, paying for demolition projects with ARPA funds; he asked how these projects were paid prior to the availability of ARPA funds. Mr. Fiscus said the City received one grant for \$150,000 and the City budgeted for the expense on an annual basis.

Mr. McLaren asked about proposed Resolution #83-22 to transfer a parcel from the City to the Redevelopment Authority. Mr. Fiscus said the parcel is located on Strawbridge Avenue, directly behind Diehl Automotive; the City demolished a house and bought the property.

CITIZENS: Dave McLaren, 1113 Haig Street; asked about activities of the various boards and committees. He suggested meeting minutes or reporting be provided to Council and then reported to the citizens. Mrs. Bundrant said members of Council are on many of the boards and activities are reported as needed. The meetings are open for the public to attend, and dates and times are published on the City's website. Brian Kepple attends Council meetings to report the activities of the Recreation and Beautifications Commissions. Mr. Fiscus said activity and reporting varies by committee. Some are city-sponsored and recognized; some are citizen-organized. City-sponsored boards act independently without oversight from Council or City Administration. One example is the Redevelopment Authority; at one time this Authority was comprised of Council members and City employees. It is now set up to be independent. He agreed having minutes from their meetings would be ideal. Mr. Sizer said it is a good idea and committee chairs can be asked to make the minutes available in the City Building.

MR. JAMES: No comments.

**MR. SIZER:** Mr. Sizer said before he was on Council an Ordinance was passed to lift residency for one of the bargaining groups. At that time, he was upset about it and thought this was a bad idea. He still does not like it; but understands why we need to do it.

MR. KOERTH: Mr. Koerth agreed with comments from Mr. Sizer.

Mr. Koerth asked if the lot at 529 Nimick Street will be made available to Lots to Love in the near future and if someone from Ohio can participate in Lots to Love. Suzanne Kepple said those questions should be directed to Christina Campbell. Mr. Fiscus said a sponsor from Ohio would be accepted; ownership would need to be evaluated. Mr. Koerth said an individual who resides in Ohio is interested in taking care of an empty lot.

MR. GALASKA: No comments.

**MRS. BUNDRANT:** Mrs. Bundrant said she feels the same about residency as Mr. Sizer, but understands why it is necessary.
