CITY MANAGER'S REPORT

- Sharon Revitalization and Investment Grants Mr. Fiscus recommended Council approve a \$50,000 Revitalization Grant to Our Gang's for kitchen expansion and an enlargement to the outdoor receiving area.
- Collective Bargaining Agreement FOP Mr. Fiscus said the FOP recently voted on the CBA and there is a tentative agreement for the ratification of a 5-year collective bargaining agreement. Documents are being prepared for final reading next month.
- Update Comprehensive Plan Mr. Fiscus said there was a meeting with Comprehensive Plan consultants today; they are beginning to reach out to stakeholders. He will provide an update at each Workshop Meeting and take back feedback to the planners. It is exciting to have a solid plan in place to help navigate as we see the growth. MR. JAMES: None

MR. SIZER: Mr. Sizer thanked Jason, Jessica, and Bob for their work on the budget and fourteen years of not raising taxes. The 2020 budget was \$8.9 million in revenues and expenses, and the proposed 2024 budget is \$10.7 million, and was balanced without raising taxes. He said it is not easy to do and is a lot of hard work and he appreciates it. Mrs. Bundrant said it was a job well done.

MR. KOERTH: Mr. Koerth commended on a great job at the recent fire at The Block. He asked why the sprinkler was shut off and turned back on in 2021. Mr. Fiscus said he is unsure, but it appears it was turned off while the building was in between occupancies. There was an issue with a broken sprinkler pipe, and it was turned off with the expectation that it be turned back on after repairs were completed. As part of the inspection process, the Fire Inspector discovered it was turned off while ensuring that all fire protection systems were working.

MR. GALASKA:

MRS. BUNDRANT: Mrs. Bundrant said Small Business Saturday will be on Saturday, November 25, 2023. There will be festivities throughout the day. Come down and shop and take advantage of what Downtown has to offer.

Mrs. Bundrant reminded that the Second Budget Hearing will be on Wednesday, November 29, 2023, at 6:00 PM. Also, due to the holidays, there will be one meeting in December, on December 6, 2023, starting at 6:30 PM.

CITIZENS:

Ben Griffin, 528 Dwyer Way; Mr. Griffin asked Mr. Fiscus about the intersection of Columbia and Irvine; he said he asked about a month and a half ago about the light posts; they left the studs and cement, and he is concerned when the snow falls someone is going to trip. Mr. Fiscus said he had previously answered incorrectly based on information provided to him. Of the four corners, there are two with new concrete; the other two were not removed because it was not part of the contract, and we need to come up with a better plan for those. Mr. Griffin said someone is going to fall and asked how much more it will cost to knock the concrete out and take the studs out. Mr. Fiscus said he appreciated his comments.

Mr. Griffin said he noticed there are not handicapped accessibilities across Columbia Street due to the manhole cover and drain sewer. Handicapped accessibilities were installed coming out on Irvine but not going across Connelly Blvd. Mr. Fiscus said he had not specifically noticed that, but the City hired an engineering firm specializing in ADA accessibility and they had to obtain special permissions from PennDOT to proceed with the project because it was difficult to get the appropriate grades with the steep hill. Mr. Griffin asked Mr. Fiscus to look at it; people with disabilities must come out onto Irvine then come across Irvine to get back onto the sidewalk again.
