#### **CITY MANAGER'S REPORT**

- Code Appeals Fee Mr. Fiscus said there is a fee in the current fee structure named "Rental Code Appeals Fee". We need to add or amend it to be a General Code Appeals Fee, which is \$600. Attorney Stedman said the new Ordinance will create a new fee for all appeals under the Code Appeals Board provision of the Ordinance. Mr. Fiscus said this is a conservative fee amount, the actual cost is somewhat higher than \$600, and this will bring it closer to break-even.
- Rental License Ordinance Mr. Fiscus said Attorney Stedman, the Fire Department, and the Rental Inspection staff have worked diligently to update the Rental License Ordinance. There are areas in the old Ordinance that are conflicting and as sections were amended, it became difficult to understand the proper action to be taken. The new Ordinance is simpler, it will provide better service to the property owners and residents who live at the properties, and it is enforceable by the Code and Fire Officials administering it. The Ordinance is available to be reviewed and there will be a Public Hearing in two (2) weeks. The first reading will be held today, a Public Hearing will be held on April 3, 2024, followed by the second reading on April 3, 2024.
- Bid Results 2022 Green Light Go Mr. Fiscus said the bid for this grant funded project is \$343,000.
- Supplement #3 East State Street Project Mr. Fiscus said PennDOT is requiring one more easement, so an amendment is needed for this grant funded project.
- Letter of Understanding Motor Carrier Enforcement Chief Stabile said this is a standard Letter of Understanding outlining our requirements to maintain Officer Fosler's certification as a motor carrier enforcement officer
- Conciliation Agreement HUD Attorney Stedman said a complaint was made against the City and other municipalities in the Shenango Valley by a group home operator regarding our obligation to enforce the Uniform Construction Code under Pennsylvania Law. They opposed the requirement that group homes have certain sprinkler facilities. This is basically an agreement that says in the event that PA, through the UCC, should ever change the requirement that sprinkler facilities must be installed, the City would follow that lead and also not require them to be installed. As the State sets the UCC, we are obligated to follow that anyway. It further provides for clarification in our Zoning Ordinance ensuring that group homes be treated as single family dwellings, as required by federal law. Mr. Stedman said he is confident the Ordinance already does this; they requested clarification, and we will be obliged to do that.

#### **CITY MANAGER:**

Mr. Fiscus thanked Courtney and Sherris for all of their hard work to make the St. Patrick's Day Parade a success. They have done a great job. We are nearing the end of the contract with them, and they have made huge contributions to Sharon and the eco-system created Downtown is because of their successes. He would like to celebrate their successes with them at the end of the next Council Meeting.

#### **CITIZENS:**

- Judy Henderson, 1010 Sherman Avenue; Ms. Henderson said the issue with the camper parked on French/Sherman has been solved. On behalf of herself and other residents, she thanked Council, Mr. Tomko, Mr. Kepple, Mr. Rossi, and the Police Department for resolving this problem.
- Mary Ann Phillips, 1339 Kimberly Road; Ms. Phillips asked who audits the ARPA Grants. Jason Tomko said Mark Turnley, CPA, is the City's outside, independent auditor and is responsible for auditing the grants.

Ms. Phillips cited the recent conflicting articles/news stories about the Shenango Inn and asked what was happening. She said there is another broken window and a storm door in the rear of the building that appears to be broken. Mr. Fiscus said he recently spoke to Mr. Yanko, the owner, who said the project would not be moving forward, as the funding was not there, the banking system is no longer viable, interest rates are much higher, and the business model no longer works. Mr. Yanko floated several options but made no formal proposal. In a later phone call, Mr. Yanko said the other options are no longer working and he would not be making a formal proposal and is looking for a buyer. Mr. Fiscus relayed this information in an interview with a news reporter. Shortly afterward, Mr. Yanko again called and said he had great news, he found financing, and the project would be moving forward. Mr. Fiscus said the article mentioned Mr. Yanko would need money from the City. As the City is nearing the end of programming the ARPA money, Mr. Fiscus is uncertain that he would be in a position to recommend Council fund this project under the current conditions. Ms. Phillips said Mr. Yanko is looking for \$1 million in ARPA Funds. Mr. Fiscus said an amount that size was never discussed for the Shenango Inn. Mr. Fiscus said the City will continue with Code Enforcement following legislation that is in place. Ms. Phillips asked about the time limit of this project and could it go on forever. Mr. Fiscus said timelines exist for things such as broken windows, unsafe, unsecured building conditions. He said a code officer is not at the building on a daily basis and asked that issues be reported to Code or the non-emergency 911 number. Mrs. Bundrant said she shares in the frustration about the property. Mrs. Phillips asked if Mr. Yanko receives notification when notices are posted on the building. Mr. Fiscus said Mr. Yanko does receive notification and has been responsive when he receives those notices.
