CITIZENS:

Kathy Testani, 417 Wilson; Ms. Testani noted that the trash conversation from last meeting was tabled. Using one bag per week works perfectly for her, but she still does not think everybody has trash service.

Ms. Testani said that she has been complaining about 618 Wood Way since it was bought by Terry Whalen in 2021. Dave Tomko listened to her complaints in the past; she found out that the property is no longer on the condemned list because it was signed off last year by Mr. Tomko, although nothing has been done. She does not understand how it was removed from the condemned list. She said the property he owns on Wilson Street has new glass and windows; nobody has been in there since at least 2000. New steps have been installed on Jarrett's property, but the house has not been kept.

Ms. Testani said Tyler Technologies was in her area on Monday, but they did not leave a card or any other information. Mrs. Bundrant advised her to call Tyler Technologies.

Ms. Testani asked what was happening at the former Julian's site; she heard a pizza restaurant was moving there. Mr. Fiscus said there are parties interested in the site but has no distinct names at this time.

William DuBose, 419 Madison Street; Mr. DuBose recently moved to Sharon from Texas and California; Sharon is great, but he does see some concerns after being here for a year. The sidewalk improvements on Irvine Avenue are great. He is concerned for elderly neighbors and said every neighborhood in the City needs to be represented and kept the same as all the others; if not it is a lacking to the seats held by Council. At minimum there should be some type of chemical to get rid of overgrown grass. Mrs. Bundrant asked if there was a specific concern that Council could address for him as Council is aware of overgrown grass and sidewalks that need to be replaced. Mr. DuBose said he understands the freedom to own property, have landlords, and rental homes. He observed a group home on his street with heavy traffic and illicit activity, and drug sales; this is not something that should happen in any part of Sharon. As a City, we have landlords operating, and anything is allowed for group homes and activities impacting neighborhoods. Mrs. Bundrant said the City cannot prohibit who is rented to, but there are some safeguards in place for the actual homes. Mr. DuBose asked who allowed a group home to be put on Madison Street. Mr. Fiscus said it would be discriminatory to prohibit a group home. Mrs. Bundrant advised him to call law enforcement when he sees illegal activity. Mr. DuBose said he has but it is not a practical solution as law enforcement arrives after the fact. Mrs. Bundrant encouraged Mr. DuBose to continue attending Council Meetings as Council discusses issues on an ongoing basis. If he is able to attend in the future, it would be appreciated for him to listen and try to be a part of the solutions and possibly join Boards or Commissions. She said taking back neighborhoods will be a slow and gradual process and the Comprehensive Plan is another part of this.
