CITY MANAGER'S REPORT

- ARLE Projects Acting City Manager Jason Tomko addressed two resolutions on the meeting agenda related to ARLE (Automated Red-Light Enforcement) funded projects:
 - Resolution #39-25 Seeks approval for an engineering contract with Trans Associates for the North Sharpsville Avenue/Pitt Street Safety Improvements Project. This project includes installation of lights, crosswalks, and ADA-compliant ramp improvements. The Project is fully funded through ARLE.
 - Resolution #32-25 Approves a contract with Trans Associates for an \$85,000 traffic signal backplate installation project, which aims to improve intersection visibility by adding reflective tape to signal backplates at various intersections. This Project is fully funded through ARLE.

PUBLIC COMMENTS - AGENDA ITEMS

- Melissa Klaric, The Herald; Ms. Klaric requested additional information regarding the ARLE Backplate Installation Project. Mr. Tomko said the project will address all signalized intersections throughout the City. Reflective tape will be installed on the backplates behind the traffic lights to improve visibility and make the signals more noticeable to drivers.
- Staci Hagood (Torrence) spoke in support of Ordinance #04-2025, which proposes naming an alley "Torrence Way." She introduced her husband, Jay Hagood; her brother, Kelvin Torrence; and her uncle, David Torrence. Ms. Hagood identified herself as the daughter of Marlene and Kenny Torrence. She has taken over her parents' home on A Street, where they lived since 1972 and raised five children. She expressed pride in her family's contributions to the community. Her father, Kenny Torrence, served as a police officer in the City for 27 years and was widely respected. Her mother, Marlene Torrence, was active in civic life, including voter engagement and working at the polls. Ms. Hagood emphasized the family's connection to the City of Sharon.
