CITIZENS:

- Kathy Testani, 417 Wilson Street; Ms. Testani said when speaking at a Council Meeting, she understands that residents must give their name and address for the record and what is heard is public knowledge. However, when she talks with a City department head, she expects the conversation to be anonymous; She was informed that Mr. Whalen and his team know who she is, where she lives, and that she has complained. She said she has been complaining about Mr. Whalen's properties on the West Hill and has pictures dated back to 2022, and it is still a mess. Ms. Testani asked if Mr. Whalen has a deal with the city or not? He has a house on Wilson Street that nobody has lived in 20 years. Attorney Stedman said this is generally protected information; however, if you make a complaint, it is not subject to the right to know law.
- Debbie Pickens, 629 Sherman Avenue; Ms. Pickens asked for clarification regarding the parking ordinance for trailers, boats, motor homes, uninspected cars. Mr. Fiscus said if it is parked on the street, report it on the nonemergency 911 line and the police will handle it. If it is on somebody's property, then report it to the Code Department. Motor Homes, boats, trailers are not allowed to be parked on the street overnight.

Ms. Pickens asked what is happening with the Phoenix building. Mr. Fiscus said there is no update.

- Ms. Pickens asked who schedules the date of Waterfire. This year, it is the same date as the Hermitage Arts Festival and Gus Macker Tournament. Mr. Fiscus said Waterfire schedules the dates. Mrs. Bundrant said the only group that has control over the date is the Hermitage Arts Festival.
- Terence Whalen, Owner of Shenango Valley Homes; Mr. Whalen said nobody from Council or the Code Department gave him Ms. Testani's name. He said work is being done and repairs have commenced on the house at 618 Wood Way: trees were cut down, windows were replaced, wiring and the electric is now running, and there were problems with and relocation of National Fuel Gas lines. Mrs. Bundrant suggested he and Ms. Testani talk after the meeting.
 - Mr. Whalen asked where the sewer fees and delinquency fees are published. Mrs. Bundrant provided him with a draft copy of Resolution 50-25. The fees will be published on the City's website.
- Hirman Griffin, 1082 Woodland Place; Mr. Griffin said there is a family of raccoons coming out of the storm sewers in his neighborhood. He asked if something could be put over the grates. Mr. Fiscus said if screens were installed, there could be the potential for flooding, but he will look into solutions. He said to call the Game Commission if raccoons are coming out during daylight hours.
 - Mr. Griffin said Tri County is not picking up garbage alongside the cans if the claw cannot pick it up. Mr. Fiscus asked him to call his office when this happens, and they will contact Tri County Industries.
- James Epstein, 1339 Kimberly; Mr. Epstein asked if the City is able to obtain a list of services now open and available at Sharon Regional Medical Center. Mr. Fiscus said he will obtain information on services and have it available at the next meeting.

Mr. Epstein asked about the amendment to the zoning ordinance that authorized a hotel to operate at the former Shenango Inn and whether it is still in effect, or if there is a sunset clause. Attorney Stedman said if you amend the zoning ordinance, it does not sunset. The only thing that can sunset is when a variance is granted. Mr. Fiscus said that there is a timeline in the amended Ordinance stating construction had to end within a time limit of when it began; in this case it never started. Mr. Epstein asked if this is for this particular hotel or any hotel built. Mr. Sizer said this needs to be checked.
